In the event that the seller detects product nonconformity in any lot or batch from which product has been sold to purchaser, it is requested to notify purchaser immediately of the nonconformity. The seller is request to notify purchaser if product definition is altered. Purchaser reserves the right to request inspection of all facilities and records associated with the purchase order, and reserves the same rights for its clients and all applicable regulatory authorities. The seller also agrees to furnish, as requested, all certificates of conformity, airworthiness approval, or other documents associated with ensuring the conformity and integrity of the products sold.

The seller certifies that its calibration system meets or exceeds the MIL-STD-45662A standard, and that its Quality Management System meets or exceeds the ISO9001 International Standard. M3 Technology and its customers reserve the right to obtain verification of compliance to these standards. Unless otherwise noted, all DFARS requirements apply to this Order and any and all work associated with it. All US and International laws apply to this order, and in signing below, the Seller represents that it has not violated the EAR or ITAR, and will advise the Purchase if the company, its officers or ownership have been found in violation of these or any other regulations.
